VI. Unfinished Business - None
VII. New Business
A. Elections Slogan/Theme - Discussion Item

The Commission discussed various ideas for slogans and themes to be used for this year's ASI election season, with the established goal being to choose a slogan that is short and concise. The topic of color scheme was discussed, with the choice being between red, white, and blue or CSUDH spirit colors. Janes shared that he will ask the graphic designer to create
sample materials, with alternative versions using the different color scheme ideas. He will bring the sheets for approval to the next meeting, where adjustments can be decided upon.
B. Elections Merchandise and Giveaways - Discussion Item The Commission discussed possible promotional items and giveaways for 2019 - 2020 General Elections. Item ideas discussed included: custom chip bags, stickers, shirts, pens, buttons, tote bags, drawstring bags, fidgets objects, keychains, lanyards, bracelets, beanies, caps, and reusable straws with promotional packaging. Anger noted that reusable/sustainable products are currently popular amongst the student body. The Commission will determine a list of 8-9 items to narrow down. Janes noted that the material of bags or other items will affect the prices. Marin noted that in the selection of items, visibility should be taken into consideration. It was clarified that the promotional items being discussed are separate from the prizes (giveaways) given during the elections season. On the topic of prizes, Jackson suggested increasing the prize budget up from $\$ 1,200$, either adding another prize or raising the price value of the same number of prizes (he gave the idea of a portable power bank as a prize idea). Janes shared that last year, the goal of approximately 1,200 voters was surpassed, with approximately 1,500 people participating; now a new goal can be set for the upcoming elections. Janes shared a prize idea of offering a VIP package for the Spring Fling concert event, which the recipient would be given 4 tickets, line-jumping privilege, food vouchers, and up-close seating during the concert.
Upon inquiry about the budget specifically for the elections, Janes shared that the budget is $\$ 7,700$, of which Big Pulse takes $\$ 4,000$. Janes also shared that the election applications are typically available in November but can be made available earlier; they applications are due in February. The election events will begin around February-March. Townsend requested specific days to be determined for the events for the sake of budgeting.

## VIII. Reports

President - Jackson reported that he has been in contact with the Chancellor's Office, there is still uncertainty around requirements decisions.

Program Coordinator - Welcome Week will take place next week. On Tuesday $9 / 1$, the ASI office will host its open house tours, in which participants will be given food vouchers; also on that day, the Commuter Outreach event will take place, during which ASI will hand out coffee and donuts to students. On Wednesday from 4:00 PM - 5:00 PM, Starbucks will
be providing the coffee to hand out to students. On Thursday from 11:00 AM - 3:00 PM the Involvement Fair will take place, during which an opportunity drawing will take place for students to win tickets to CSU Dominguez Hills Night at Dodgers Stadium and Halloween Horror Nights. On Wednesday evening, the BOD Involvement Mixer will be held, where food vouchers will also be available for participants.

Elections Commissioner - Marin shared that he attended the New Student Convocation, where he educated freshman students about ASI.
IX. Open Forum - Discussion Item

Time for members of the audience to address the Commission.

Jackson shared that two students have contacted him requesting more information about the quantitative requirements. He clarified to the Commission that ASI's concern regarding the quantitative requirements is access to higher education; ASI does not want students' geographic location or access to academic resources to prevent them from higher education in the CSU system due to inability to meet the quantitative requirements. Currently, approximately $50 \%$ of LAUSD graduates are not eligible to attend a CSU under the current requirements.
