Alvarado recaps last meetings business allocated money to the Scholars United Club Uniting Cars event, some adjustments pertaining costs were made by the club to save money.

Luke Peck (Scholars United President), states money allocated for speakers, club found a way to save money on the speakers and instead would like to allocate remaining funding to the DJ for the event. (\$400) Budget shown by Castaneda shows items approved and states the remaining funds total to \$278. Increased requested amount \$1,181.35, previous approved amount was \$1,160. Peck afterwards placed in the waiting room while the commission discusses on request. Peck states not asking for more money but just to allocate money for DJ. Peck suggests DJ could provide the invoice for \$380 and the rest of the funds will be utilized for other items. Castenda states \$1161.35 is the new revised amount of funds. Chair allocates for the \$300 to Scholars United, Castaneda point of order to chairperson to specify exact amount given to Scholars United. Entertain the motion for \$381.35 by Chair porta potties \$300 and handwashing station \$100 DJ \$380, for a total of \$1161.35.
