B. Culture & Identity Center Referendum Budget Review – Discussion/Action Item The Commission will discuss and consider approving the CIC's 2023-2024 budget proposals.

Toro Dreamers Success Center – Barragan presents on what the ASI funding has done in the past year for the center. Some of the funding has impacted directly and indirectly the lives of students. The budget proposal for 2023-24 is for programing, marketing, appliances and decorations, fellowships. They are requesting for \$16,000.

Queer Culture and Resource Center – On behalf of Teagle presents QCRC's budget proposal. OCRC is focusing more on outreach, as well as focusing on community. Proposed budget is set to be used for special events, supplies and services, instate travel, dues and memberships totaling out to \$16,000.

Rose Black Resource Center – Davis, newly appointed Interim Director of the CSUDH Black Resource Center (BRC), services advising, mentorship, student employment, mental health. BRC programming, office supplies, marketing materials to be part of the 2023-24 proposed budget, totaling \$16,000.

La Casita – Castellanos and Martinez (program coordinator) budget review contains dues and memberships, supplies and services, and special events for the next year totaling \$16,000.
