### VIII. New Business

A. Revenue Sharing Policy – Action Item

The Commission will consider changes to the Revenue Sharing Policy to be effective for the 23-24 academic year.

Accounting Clerk – Castaneda-Patino went over updates previously discussed by the last Finance Commission and suggested that the Revenue Sharing Policy be revised to no longer have the funds placed directly into club accounts. Clubs would instead submit a Revenue Sharing Funds Request Form to Accounting Clerk and Executive Director to request use of funds. In this case if the club does not use the funds by the end of their term, the funds would directly go back to ASI. This would also avoid funds sitting in club accounts untouched when it could be used for other clubs.

# B. Viewpoint Neutrality Policy – Action Item

The Commission will consider changes to the Viewpoint Neutrality Policy.

Viewpoint Neutrality Policy has been established among all CSUs. As long as the process is being followed correctly, there is no reason personal viewpoints should be involved in the acceptance or neglect of requested funds. Castaneda-Patino discusses making changes to page 2, Affected Organizations section. Change "Using the Referendum Entity Request Form" to "during the budget season" for the Cultural and Identity Centers to present their entire budget and explain what funds are being used for the year at the Finance Commission. Additionally, update the Rose Black Resource Center to Black Resource Center, Toro Dreamers Success Center to Immigrant Justice Center, and add the Latinx Cultural Resource Center, as well as the Asian & Pacific Cultural Center. Remove "petition the Finance Commission" and replace it with "submit a Referendum Entity Request Form per semester to the Accounting Clerk." Also, remove the phrase "using the Referendum Entity Request From."

\*M/Martinez, S/Gonzalez to approve the changes to the Viewpoint Neutrality Policy. **VOTE: UNANIMOUS**
