Before You Vote" event is scheduled for November 4th from 3:30 to 4:30 PM in LSU Rooms 324-325. During this event, Grave is asking the committee to familiarize themselves with several propositions they will be presenting, specifically focusing on Propositions 5, 4, 2, and 6.

Huitzacua will focus on Proposition 5, Campbell on Proposition 6, Alvarez on Proposition 2, and Gonzalez on Proposition 4. Proposition 6 proposes to remove the law that allows incarcerated individuals to work as punishment for their crimes. Proposition 2 authorizes billions in bonds for various needs, while Proposition 5 addresses affordable housing and infrastructure bonds, and Proposition 4 pertains to water issues.

This information will be useful for her to bring up at the event. Huitzacua mentioned that some of them will be present to answer questions from students during the presentation. They are also considering organizing a Jeopardy-style game to encourage engagement, possibly with a prize. The committee has agreed to assist Scarlet with the presentation.
