Emmert mentioned that the extended deadline is today. She also noted that two drip campaigns are currently underway: one for the ASI pick-up app, which encourages users to pick up their items, and another for the ASI pick-up app group, which provides updates on events and encourages sign-ups. When candidates begin their campaigns, we will also reach out to inform them about how and where they can vote. Regarding filming for our social media page, our social media programming assistant will only be able to film this committee, so he will be reaching out to coordinate schedules. Truong mentioned that he spoke to Jessica, and we are set to distribute a parking pass once we reach a certain tier level for voters. Huitzacua suggested creating a handout to inform people about the voting process. Gonzalez proposed potentially having classroom presentations to demonstrate to students how to vote.

B. Election Application Updates – Discussion Item The committee will discuss application updates.

Emmert reported that we have given out a total of 62 applications. Out of these, 55 are currently active on Emma, the platform we are using. Additionally, 18 applications have been turned back in. She believes that some applicants may have graduated in the fall semester, which could explain why we were unable to retain them.

The breakdown of applications is as follows:

- 2 for Director of Legislative Affairs
- 1 for Elections Commissioner
- 2 for Executive Vice President
- 4 for Student Activities Commissioner
- 2 for President
- 2 for Directors of Student Services
- 1 for the College of Natural and Behavioral Sciences Representative
- 1 for Vice President of Finance
- 1 for International Students Representative

There is one ineligible candidate; however, they will be informed of their right to appeal.
