Martinez went over the student headcount 13,700. Shakoor noted that the university is predicting to remain level, considering last year the enrollment numbers were nearing 14,242 The travel expenses have decreased significantly in regards to the number of attendees attending CHESS. There will now be only four members going to the event. This is because there has been an increase in transportation prices, hotel prices, and more. Cowo suggested that only four people should go to CSUnity and all the Board of Directors (BOD) members attend CHESS events. Shakoor reminded the commission that CS Unity is meant for the Board of Directors to connect with other campuses, and if they feel they're not gaining much from that experience the commission can make a few changes. The current ASI President requested \$500 for the Executive Board to as spending dollars. BOD Development are ASI provided funds which are to support the leadership and professional staff development. This is typically where money for January, Transition, and Summer Retreat. Student Fellowships total for this upcoming fiscal year is \$102,100 whereas last year it was \$97,000. *M/Contreras, S/Cowo approved the ASI Administrative Budget for the

Lakey believes that by separating them on forms, students may not know that Student Activity funds are also available to them. Mejia-Alezano believes that we should bold the difference between student activities and Clubs/organizations. He also believes that instead of listening to the differences and rules, we should put them separate so students can view the differences.
