B. Review of Meeting Structure – Discussion Item

The Commission will discuss Parliamentary Procedure, Meeting Structure, Program Partnership Request Forms, and Viewpoint Neutrality Policy.

The Commission explained that there are two pools of money, apart from fundraising, from which clubs can request funds: the Student Activities Commission and the Student Organization Commission. The funds are available once the request is submitted on the ASI website or through Castenada-Patino's Virtual Office. Shakoor clarified that clubs can obtain funds from outside organizations, but they must be strategic in their approach. The Commission informed clubs that to spend their ASI funds, they would have to meet with Castenada-Patino to place an order, and that this process takes approximately 6 weeks, so clubs must plan their events around this estimate. Clubs inquired about the time limit for accessing their approved funds, and Shakoor advised them to consult with Patino for the best course of action to ensure those funds are used on time. Regarding fundraising, the funds are still there for you when deposited through ASI, so long as the club is in good standing. Registration fees for club members to attend conferences and events are available upon request. Fill out the Program Partnership Request. Each Club can receive up to \$500 from ASI funding.

C. Indian Students Organization Request – Discussion/Action Item

The Commission will discuss and consider the Indian Students Organization's funding request.

They are seeking startup funding, \$100 to purchase merchandise for the clubs to distribute to students while tabling. Such merchandise includes stickers and stationery.
