A. Review of ASI Club Points System – Discussion Item

The ASI Accounting Specialist will review the Club Point System.

There is a matrix of certain activities that gives a different number of points to clubs/organizations, and these are all added up, and the top three clubs/organizations with the most points at the last Organizations Commission meeting of the academic year get a prize. This matrix of the Club Point System is found on the ASI website. Patino states that not all points are automatically entered; some must be entered manually by the clubs/organizations on Torolink. The club point matrix outlines which points need to be entered on Torolink. There is a new activity added into the matrix, and that is checking in members present in their meetings/events through Torolink to encourage the use of Torolink. Patino clarifies that there is a deadline to submit for club points, and it is no more than a week from the date of the event, because it would be invalid otherwise- she will honor if a club/organization submits something from two weeks ago from now since she hasn't received any club point requests. Patino states there is no maximum number of sponsored events between organizations, so long as the organizations working together all submit their event on Torolink.

The three clubs with the most points would win different funding amounts depending on what placement they get: first place \$300, second place \$200, third place \$100 – and this funding is on top of their semester max approval request of \$500. Patino updated the organizations on their status when asked.

B. Political Science Club Request – Discussion/Action Item

He is asking for Volunteers for Discover Dominguez; only DH students can participate. Patino states that if an organization has funds today, it to contact her to set up the event. This year, we have a big budget since the Commission approved more funding for startup funds, and to cover registration fees; therefore, organizations should submit their PPR form to secure funds. The Commission recommends submitting the PPR fee six weeks before the day of the event.

Patino clarifies that the startup fee is different from the \$500 maximum funding per organization for their general events. She states that if an organization is seeking funding above \$500, it would have to request it from the Student Activities Commission. Public Health Toros Association shares with the Commission their upcoming events: Blood Drive and Wellness on the Lawn.
